Based on the experience of the global medical device and pharmaceutical industries, in June 2020 the GS1 Healthcare Global Trade Item Number® (GTIN®) Allocation Rules were updated with the aim to improve their use in regulation, supply chain and point of care applications. To assist in understanding and applying the changes, GS1 has created a number of informative and interactive tools available for all stakeholders.

FOR IMMEDIATE RELEASE – 30 June 2020. GS1 Healthcare has developed and promoted global industry standards to prevent medical errors, combat counterfeit products and improve supply chain efficiencies throughout the global healthcare industry.

The **Healthcare GTIN® Allocation Rules** help industry make consistent decisions about how to manage the unique identification of trade items, therefore contributing to improved supply chain efficiency and patient safety. The unique identification of trade items is critical to maintaining operational efficiencies that business partners rely on to exchange information about products in consistent ways, as well as ensuring the smooth operations of global supply chains, while supporting the implementation of various regulatory requirements across the globe. The communication of unique identification changes between trading partners is also essential to ensure the right product is made available when needed.

Since the development of the original Healthcare allocation rules over a decade ago, new regulations, new business processes and new requirements have triggered the need for clarifications of the Healthcare GTIN® Allocation Rules. Release 10.0 was therefore published after ratification of the updates in the identification of items and in the broader implementation of GS1 standards in the healthcare industry rules. This revision will streamline the use of the rules, and help companies better understand situations where healthcare specific rules apply.

These rules have been developed in accordance with the GS1 Global Standards Management Process (GSMP) and are considered a part of the GS1 system of standards.

All the Healthcare GTIN® Allocation Rules and the three guiding principles need to be taken into consideration when making the final decision about allocating GTINs® to healthcare products.
